



**13<sup>th</sup> Annual American Legion Junior Shooting Sports Program**  
**Department Championship Tournament**  
***Sponsored By:* The American Legion of Iowa**  
**March 24, 2018**

**The American Legion Junior Shooting Sports Program** encourages marksmanship and gun safety education for junior high and high school age youth. As part of the program, The American Legion of Iowa will conduct an Air Rifle Championship Tournament, which provides competitors an opportunity to test their marksmanship ability in competition with other shooters throughout Iowa. The 2016-2018 National Standard Three-Position Air Rifle Rules will govern the Match.

**ELIGIBILITY**

Shooters must be in a club that is affiliated with an American Legion Post in Iowa. If shooter is NOT an Iowa resident, a non-compete statement will be required. Clarification: A shooter that is a member of an Iowa American Legion Shooting Team, cannot compete in another state under The American Legion JSSP. For all other competitions, see Rule No.3.2.6 of the 2016 – 2018 National Standard Three-Position Air Rifle Rules.

Posts wishing to sponsor a new shooting club for this competition must have the **official affiliation** by **December 31, 2017**. Coaches and adult leaders are encouraged to send their best shooters in accordance with the rules and abilities.

The Department Match will be a Best-Four-Count Team (five shooters, 4 top scores count) as outlined under Rule 3.2.2, in the 2016-2018 National Standard Three-Position Air Rifle Rules. Additional shooters will be accepted up to range capacity. If range capacity is exceeded, teams will be asked to limit on a pro-rated basis.

Coaches are responsible for ensuring his/her shooters are knowledgeable of the rules and standards of The American Legion of Iowa JSSP Championship Tournament.

**FACILITIES AND EQUIPMENT**

Twelve (12) firing points with 12 box target traps and backdrop will be provided by Department. Targets will be provided to each shooter with their name and competition number at check-in.

**All equipment required for firing, INCLUDING EYE PROTECTION, will be the responsibility of the shooter/team.**

All competitors' clothing items must meet inspection standards for the class of rifle.

## FOOD

A concession stand will be in operation at the facility and proceeds shall go to the host organization. All shooting competitors will receive a lunch ticket.

## ENTRIES

**Registration and Medical forms (for all shooters) are due to Department by March 1, 2018.** E-mail (programs@ialegion.org) or faxed (515-282-7583) forms are acceptable. If mailed, forms will be sent to: The American Legion of Iowa, ATTN: JSSP Match, 720 Lyon St., Des Moines, Iowa 50309. **Forms that are incomplete or missing information will be returned and not accepted until complete!**

## CLASSIFICATION

For purposes of awards, shooters will be divided into three categories, based on age **on their birthday in 2018.** All shooters must be enrolled in a club that is affiliated with an Iowa Legion Post and must sign a non-compete statement.

**Age Group 1:** Competitors who reach their 17th or 18th birthday in the calendar year of the competition or who are older than 18 and still meet the eligibility criteria for School Age competitors.

**Age Group 2:** Competitors who reach their 15th or 16th birthday in the calendar year of the competition.

**Age Group 3:** Competitors who have not reached their 15th birthday in the calendar year of competition.

## COURSE OF FIRE (Sporter)

**3 x 20 Match:** 20 shots each in prone; standing; and kneeling.

## RULES

The 2016-2018 National Standard Three-Position Air Rifle Rules will govern the match.

Trigger pull weights (1.5 lbs.) will be tested and all equipment and clothing will be inspected at check-in. A 'safety shooting can' will be provided. Safety glasses are recommended. Once inspected and cleared, each rifle will display the inspection sticker of the Match. The equipment/rifle **WILL NOT** leave the holding area until ready to fire and then only when proceeding directly to the firing line.

Target card #1 in each stage of fire must be posted on the left side of the target box. All sighters will be fired on the left target card during each stage of fire.

## RELAY START-TIMES

All shooters are required to report not later than 1 hour prior to start time of their assigned relay! Relay assignment requests should be submitted when registering by the March 1, deadline. Unless otherwise requested, all shooters from the same team will shoot in the same relay. The JSSP Committee will assign relays as soon as practicable.

### SCORING AND CHALLENGES

The American Legion of Iowa utilizes the Orion (computerized) Scoring System, scanner, and targets at the Department Match. Manual scoring - to include plugging - WILL NOT be utilized.

**NOTE:** The Orion Scoring system uses the latest in scoring technology. Coaches/managers/trainers should be aware that the Orion scanner will produce a clear picture of each shot (without excessive tearing) **if** the pellet is expelled through a **clean and properly maintained rifle bore**. Equipment inspectors will conduct a visual inspection of the bore and advise the shooter or coach accordingly.

**First Place Team Sporter Trophy** - The top combined score of FOUR shooters from ONE sponsored shooting club.

**First Place Trophy in Age Category 1** - Top score in three positions

**First Place Trophy in Age Category 2** - Top score in three positions

**First Place Trophy in Age Category 3** - Top score in three positions

**Team Sponsorship Plaques** - To the Legion Post that sponsors Team Trophy Winner

**Second and Third Place Medals in each Age Category**

### SCHOLARSHIPS

First Place Sporter \$1,000 Scholarship (Department of Iowa Foundation Rules Apply).

Second Place Sporter \$500 Scholarship (Department of Iowa Foundation Rules Apply).

Third Place Sporter: \$250 Scholarship (Department of Iowa Foundation Rules Apply).
