Riders across the state visit these long-term care facilities, and present every Veteran there with a

flag, an official Thank You for their service, and the honor many never received.

One event worth noting was our inclusion, through the efforts of Chapter 232 in Polk City, in the

Veterans Appreciation Night at a home football game. Riders circled the track and made a tunnel

of honor for the players to take the field, as the Urbandale Legion presented the colors. I mention

this as a moment of pride. Not only did the Legion Family represent our organization well, but

the inclusion of the Riders also shows that our efforts are bringing results.

Leaving your information with the Guidance Counselor or other people general fails. I hope the proper teacher is who you ask to talk with if possible or set up a time to present the program in person. Most teachers usually have a free period sometime during the day that you could meet with them face to face generally the time frame is 40-45 minutes. Meaning you need to be ready to present your material readily and informational, demonstrating your knowledge of the program. Be sure to allow them time to ask any questions they may have to help clarify a certain point. Also be sure to inform them of the deadline dates needing to be met. Whatever the program chosen, be sure to go to Legion website and make posters and pamphlets of your program to leave with them to display on their announcement board in the room and to be displayed on the general bulletin board for the entire school body to see and read. Statistics show talking in person face to face and having a visual to aid produces the best result of information presented being absorbed and remembered. Americanism is everyone's responsibility.

Veterans Day is approaching, what does that mean or have to do with me or you. Perhaps not you personally, but it should, along with your post members, going to the school asking to do a Veterans Day assembly inviting the public to attend. #### Community Service Report

What is Community Service? One answer is that it refers to voluntary work intended to benefit the community or individuals within it. It can help various groups, including children, and people with disabilities, and can also improve local envionments, such as parks or historic building. That's a general discription. The American Legion takes this one step further. We are heavily involved in Community Service, focusing on supporting veterans, military families, and local communities. These efforts include a wide range of acrtivities, like assisting veterans through Veterans Affairs Voluntary Service, or VAVS program, providing financial assistance to families, and organizing events like blood drives an food drives.

Here's a more detailed look at our Community Service initiatives.

VAVS: The Legion actively partivilipates in VAVS program, providing over 900,000 volunteer hours annually at VA medical centers

Financial Assistance: The Legion offers programs like Temporary Financial Assistance, or TFA to help eligible veteran families with debt relief and financial stability.

Disaster Relief: The Legion provides financial assistance and support to communities affected by disasters.

Fundraising: The Legion hosts fundraising events to support veterans, military families and youth prorams.

Youth Programs: The American Legion supports youth through programs like Legion Baseball, Jr Shooting Sports and Boys and Girls State.

American Legion Riders: With over 100,000 Legion Riders in more than 2,000 Chapters acoss every domestic department and at least 3 foreign countries, the community is united in service and comaraderie.

Homesless Veterans: The American Legion is dedicated to aiding homeless veterans through advocacy, essential services and a dedicated Task Force for housing, health care and employment.

National Emergency Fund: The National Emergency Fund, created in response to Hurrican Hugo in 1989, has provided more than \$10 million in direct financial assistance to American Legion Family members and Posts.

Operation Comfort Warriors: The American Legion delivers comfort items to military

hospitals, warrior transiton units and other facilities world wide, bringing hope and support to our service members during their recovery.

Temporary Financial Assistance: Since 1925, the American Legon's Temporary Financial Assistance program has provided cash grants to support the minor children of active duty service members and American Legion members in times of need.

Volunteering: Please join the American Legion in making a meaningful impact through a variety of volunteer oppertunities that support our veterans, military families and local communities.

If applicable, the amount of money raised through fundraising efforts reported on the CPR  $\varnothing$ 

# Accuracy and completeness of data:

Ensure the information provided on the CPR is accurate and all relevant sections are filled out  $\mathcal{D}$ 

#### Timeliness of submission:

Whether the CPR was submitted by the designated deadline @

How to use the rating:

#### **Categorical rating:**

Assign a rating based on a predetermined scale (e.g., excellent, good, fair, poor) based on the overall assessment of the CPR.

# Points system:

Assign points for each category of activities reported, with higher points for impactful and diverse initiatives, and then calculate a final score.

# Important points to remember:

#### **Context matters:**

Consider the size and demographics of the local community when evaluating the post's activities.

# Transparency is key:

If there are any concerns about the accuracy of the CPR, contact the post leadership for clarification.

# **Use the CPR for improvement:**

Feedback from a CPR evaluation can be used to identify areas where a post can enhance its community involvement.

Subj: Veterans Affairs & Rehabilitation Commission Report – Fall 2025 DEC Meeting

The committee on VA & R has not met since the Department Convention meeting of July 2025. I have put together this report based on past and on-going legislative actions in the State of Iowa Legislative bodies.

HR Bill 1000, this bill is asking for the allocation of funds to help train/certify County Veterans Service Officers. It has passed the house and is currently on the floor of the Senate (when it reconvenes) for ratification.

House File 912 by: COMMITTEE on VETERAN AFFAIRS

An Act relating to state services and benefits provided to veterans, including state grants, public assistance programs, business fee waivers, substance use disorder programs, mental health and disability services, undergraduate tuition and fees, disabled veteran tax credits, department natural resources' licenses and fees, permit to carry weapons fees, vehicle registration fees, and driver's licenses, making penalties applicable, making appropriations, and including effective date provisions,

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA

USS IOWA (SSN 797) officially commissioned on 5 April 2025
VA Awards \$84M in Grants to fight Veteran Homelessness.
\$42M set aside to cover legal fees, \$42M in grants to go to case management services.

Backlog of Vets waiting for VA benefits down 45%! When President Trump took office in January, the backlog of Veterans waiting, was more than 125 days for a decision on their VA disability benefits. Claims stood at more than 264,000. That number is now down by 45%.

# VA awards nearly \$6 million in grants to fight Veteran homelessness in Iowa

Des Moines, IA - IOWA - The Department of Veterans Affairs today announced \$5.91 million in grants to five Iowa organizations to help Veterans who are homeless or at-risk of becoming homeless.

The Iowa organizations receiving grants are:

• Primary Health Care, Inc. \$981,333

• Family Alliance For Veterans of America, Inc. \$1,249,491

• Hawkeye Area Community Action Program, Inc. \$2,538,510

• Blue Valley Community Action, Inc. \$793,184

Ponca Tribe of Nebraska \$350,000

Throughout fiscal year 2026, the grants will fund the organizations as they help Veterans access:

- Housing and housing counseling
- Health care
- Financial planning services
- Childcare
- Legal assistance
- Transportation

"Supportive services like childcare, housing counseling and financial planning can be important catalysts for preventing or resolving homelessness," said Judith Johnson-Mekota, Interim Director, Veterans Integrated Service Network (VISN) 23. "These grants will help bring crucial support to thousands of Veterans in need across the nation."

The grants are among \$818 million in total funds VA is awarding nationwide through its <u>Supportive Services</u> for Veteran Families program, which provides case management and supportive services to:

• Prevent the imminent loss of a Veteran's home.

- Identify new, more suitable housing situations for individuals and families.
- Rapidly re-house Veterans and their families who are homeless and might remain homeless without assistance.

VA awards grants based on several factors, including the grant recipients' experience and past performance in providing supportive services to Veteran families, and the need in the area or community where the program will be based.

# Veterans Affairs & Rehabilitation Commission Benefits Committee

A benefit often overlooked is the access to National and State Veterans Cemeteries. Our Iowa State Veterans Cemetery is located near Van Meter, just west of Des Moines on Interstate 80. To determine eligibility you can contact the cemetery or your County Veterans Service Officer.

National Cemeteries near us are located in Keokuk, Iowa, Rock Island, Illinois and Omaha, Nebraska. To determine eligibility you can fill out a Pre-Need Burial Application on line at va.gov/burials. Determining eligibility now and locating needed information will relieve stress on family members at the time of need.

I recently toured the Omaha National Cemetery, which serves Eastern Nebraska and Western Iowa. The cemetery is 9 years old and is scheduled to inter nearly 114,000 veterans, spouses and family members. They have two committal shelters along with administration and maintenance buildings. I found it to be very well maintained and welcoming. Volunteers man the reception desk.

We will take nominations for the Val Likens Post Service Officer of the Year, until Mid Winter Conference. This is a good way to recognize the hard work of our service officers. If you have questions, contact Shane at the Service Office or myself.

Our recommendation for filing compensation and pension claims remains to use County Veterans Service Officers to organize and file the claim. Gather evidence on the local level, and then forward the claim to Shane and his staff at the American Legion Service Office in the Federal Building. We feel this makes the best use of available services.

Legislative Commission Report to the DEC October 18, 2025

The Legislative Commission has been working hard on our legislative priority, HF 1000, since our Department Convention. Our efforts have focused on building support and collaboration with key VSOs.

#### Progress on HF 1000:

- We compiled a contact list for Veterans Service Organizations (VSOs) operating out of the Federal Building, including:
  - Disabled American Veterans (DAV)
  - Veterans of Foreign Wars (VFW)
  - Paralyzed Veterans of America (PVA)
  - Vietnam Veterans of America (VVA)
  - The American Legion (AL)
- A VSO sign-on letter has been developed and we've requested a meeting with Governor Reynolds to discuss her support for HF 1000.
- Weve developed talking points for VSO members to use when meeting with their legislators, ensuring a consistent and effective message.
  - On Oct 1st, Adjutant Derner, PDC Ring and I attended the IDVA Quarterly Meeting at the Iowa Veterans Home. During the Open Discussion portion of the Agenda, Adjutant Derner spoke about the particulars about HF 1000 and how passing it would benefit all VSOs. He concluded by presenting them with the VSO sign on letter, which we intend to present to Governor Reynolds and urged them to pass it through their membership. Every VSO came to us after the meeting adjourned to get a copy of the letter. We're waiting on those results.

As we continue to focus on HF 1000, we must also address our other priorities, including the Military Homeowners Assistance Program. Despite efforts to increase funding, the program's funds are exhausted, and veterans are once again placed on a waiting list. Last session, Governor Reynolds increased funding by \$500,000, bringing the total to \$2.7 million. However, this increase was insufficient, and the program's funds were depleted again. We must prioritize addressing the funding shortfall for the Homeowners Assistance Program this session to ensure veterans receive the support they need.

Please contact your Legislators and let them know we expect their support on passing HF 1000, and we will be touching base with them on January 21st, 2025 at Veterans Day in the Hill at the Iowa State Capital.

#### Next Steps:

The Legislative Commission will continue to work on HF 1000 and the Military Homeowners Assistance Program, advocating for the needs of Iowa's veterans. We will provide updates on our progress and look forward to collaborating with the DEC and VSOs to achieve our legislative goals.
